

### Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher the number the lower your fuel bills are likely to be.

## **Environmental impact of this property**

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.

This property produces 6.4 tonnes of CO2

This property's potential production 4.3 tonnes of CO2

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 2.1 tonnes per year. This will help to protect the environment.
